Dear Parents and Carers,

You may have seen in the media the Department for Education's (DfE) announcement that schools are permitted to make Friday 18th December a 'non-teaching' day. I am writing to reassure you that we will <u>not</u> be amending our term dates or our scheduled INSET days as we recognise the significant disruption this causes our families. This means our last day of term for students will remain Friday 18th December.

Below is an extract from the DfE guidance regarding contact tracing after school ends and a table showing the arrangements for the Academy:

- Where a student or staff member tests positive for coronavirus (COVID-19), having developed symptoms more than 48 hours since being in school, <u>the school should not be contacted</u>. Parents and carers should follow contact tracing instructions provided by NHS Test and Trace.
- For the first 6 days after teaching ends, if a student or staff member tests positive for coronavirus (COVID-19), having developed symptoms within 48 hours of being in school, the school is asked to assist in identifying close contacts and advising self-isolation, as the individual may have been infectious whilst in school.
- School staff are not asked to remain on-call or conduct any contact tracing more than 6 days after the final day of teaching. Where a schools last teaching day is on Thursday 17th December, there should be no student contact tracing asks beyond Wednesday 23rd December.

To ensure these arrangements work effectively and minimise the risk of compromising families' Christmas break, please adhere to the following:

- Seek tests via testing centres rather than via postal tests as this can delay confirmation of results. From test centres results are normally forthcoming in 24 hours.
- Notify the Academy if children have symptoms. When awaiting a test result, remember it is advisable to take necessary steps whilst awaiting confirmation. Ensure you continue to adhere to social distancing protocol.
